**COMMODITY OR SERVICE: School Furniture and Supplies**

**PERIOD OF CONTRACT: 6/1/2024 through 12/31/2026**

This contract is entered into by and between the Milwaukee Board of School Directors (“MPS”) and Lakeshore Learning Materials, LLC (“Contractor”).

Whereby, MPS agrees to direct the purchase and Contractor agrees to supply such requirements of the commodity or service cited above in accordance with the Omnia Partners Contract Number R230301. This Contract is subject to any amendments to that Contract executed in the future. This Contract is made possible due to the mutual membership of Lakeshore Learning Materials, LLC to the nationwide cooperative, Omnia Partners.

Contractor acknowledges and agrees that the relationship with MPS is non-exclusive and MPS may contract with as many additional entities as MPS, in MPS’s sole discretion, sees fit.

In accordance with MPS Administration Policy 3.10, which hereby incorporated by reference, the following requirements have been assigned to this Agreement: the HUB requirement on this Contract is 0%; the Student Engagement requirement of this Contract is based upon the sliding scale shown below for the 31-month term; and the Career Education requirement for this Contract is 30 hours per 31-month term. Failure to achieve these requirements may result in the application of some or all of these sanctions set forth in Policy 3.10.
