**MILWAUKEE BOARD OF SCHOOL DIRECTORS  
 PROFESSIONAL SERVICES CONTRACT  
 FIRST EXTENSION & MODIFICATION**

On August 1, 2019, the Milwaukee Board of School Directors and Lakeside Buses of Wisconsin. (“Contractor”) entered into a Professional Services Blanket Contract number C028811 (“Contract”) with a term of August 1, 2019 through July 31, 2020. The Contract, (¶ 2), provided for two additional one-year extensions upon mutual written consent of the parties and in consideration of the performance metrics listed therein. Based on the Contractor’s achievement of those performance metrics, the parties now mutually agree to extend the Contract for the first one-year term.

As such, the Contract will be extended for a second term (“Year 2”), from August 1, 2020 through July 31, 2021 (“the First Extension”), under the same terms and conditions as set forth in the Contract, except as specifically set forth below.

In accordance with ¶ 20 of the Contract, the parties modify those terms and conditions identified below.


**MODIFIED TERMS:**

1. Paragraph 3 is modified to include the following provision: “Total compensation under this Contract for the period from August 1, 2020 through July 31, 2021 (“Year 2”) shall not exceed \$262,500.00.”


