**MILWAUKEE BOARD OF SCHOOL DIRECTORS
PROFESSIONAL SERVICES CONTRACT
SECOND EXTENSION & MODIFICATION**

On July 1, 2018, the Milwaukee Board of School Directors and Playworks Education Energized entered into Professional Services Contract number B0001321 (“Contract”), with a term of July 1, 2018 through June 30, 2019. The Contract was previously extended for a term of July 1, 2019 through June 30, 2020 (the “First Extension”). The Contract, (¶ 2), provided for two additional one-year extensions upon mutual written consent of the parties and in consideration of the performance metrics listed therein. Based on the Contractor’s achievement of those performance metrics, the parties now mutually agree to extend the Contract for the second additional one-year extension.

As such, the Contract will be extended from July 1, 2020 through June 30, 2021 (“Year 3”), under the same terms and conditions as set forth in the original Contract, except for those specifically modified below.

In accordance with (¶ 20) of the Contract, the parties modify those terms and conditions identified below.

MODIFIED TERMS:

1. Paragraph 1 is modified as follows:
 - a. Under Component B the language, “Contractor will provide full-time program staff providing recess support and training splitting on-site time between four school locations,” is deleted and replaced with, “Contractor will provide full-time program staff providing recess support and training for one school location OR splitting on-site time between two to four school locations.”
 - b. Under Component B the language, “Contractor will provide one full-time salaried staff to work among four schools with scheduling coordinated evenly among the four supported schools over the course of a full school-year. For a specific set of four schools, school names, recess times, school start, and school end times will be defined,” is deleted and replaced with, “Contractor will provide one full-time salaried staff to work at one school or split time between two, three, or four schools with scheduling coordinated evenly among the supported schools over the course of a full school-year. For a specific set of schools, school names, recess times, school start, and school end times will be defined.”
 - c. Under Component B the following language is added, "In the event of a closure greater than one week, both parties will convene to determine ways Contractor may provide programming, virtually or through other modalities, in keeping with Contractor’s program expertise. The format and frequency of delivery will be discussed by both parties to ensure feasibility, accessibility and timeliness. Activities could range from: virtually delivered programming to professional development and will be mutually agreed upon.”

2. Paragraph 3 is modified as follows: “Total compensation under this Contract for the period from July 1, 2020 through June 30, 2021 (“Year 3”) shall not exceed \$532,140.00” is added.
