Overview

The Milwaukee Public Schools Procedural Compliance Self Assessment

The Special Education Oversight Action Plan (SOAP) requires that MPS align special education staff to increase accountability and support, develop and support a system to assist parents who have concerns, or need information to navigate the MPS system, and develop and support a continuous improvement focused monitoring system (CIFM) that leads to improved service delivery, provides information regarding needed professional development and contributes to staff accountability for high level outcomes for students with disabilities.

The CIFM process had included three major monitoring oversight strategies which were developed during the 2002-03 school year and had been in place since the 2003-04 school year. The oversight strategies were:

1. Training support and monitoring of individual teachers and IEPs (Individualized Education Program). Documents are reviewed for accuracy and legal compliance with training and ongoing support provided to individual teachers and service providers as needed.
2. Review of systems within schools that are required under IDEA-2004 and not readily observable by IEP document review. Items for review include such areas as discipline procedures, attendance monitoring, and service delivery oversight. Monthly reports are used to identify areas of concern and to develop immediate plans to support and improve all areas of special education service provision.
3. Implementation of an annual school-based assessment of identified compliance items with mandatory, timely correction of all identified child specific errors.

In 2012, the DPI determined that MPS had made enough systemic progress to enable the District to use the same accountability system as the rest of the State. That accountability system is the Procedural Compliance Self Assessment (PCSA). The only difference between

MPS and the rest of the state is that MPS will be reviewed every year rather than on a rotating schedule of every five years.

In 2017, Results Driven Accountability (RDA) was the revised accountability system from the federal Office of Special Education Programs (OSEP). States were allowed to choose a focus for RDA; Wisconsin chose literacy outcomes because this is an area of challenge for many students with disabilities in the state. Thus, Wisconsin's effort retools the acronym as "Reading Drives Achievement: Success through Literacy (RDA:StL)." The revised accountability system, which used to focus solely on compliance, now includes both compliance and results.

ANNUAL PCSA ASSESSMENT

The Procedural Compliance Self Assessment (PCSA) includes a school-based assessment aspect that is completed annually during the spring. At that time a one-time annual measurement of compliance is completed at each school in the district. The results of the measurement activity provide school based and district level data. The school based data is used to form the goals and actions steps for special education compliance activities that are included in each individual School Improvement Plan (SIP). The district-wide data is used to analyze district-wide supports and to develop, if indicated, plans of improvement for district-wide systems serving students with disabilities.

Each school will receive the results of the 2018-19 PCSA with the expectation that data will be included in the school wide planning for the 2019-20 school year. Each school is required to include plans within the School Improvement Plan to address all of the individual compliance items that were measured below 100% and therefore considered to be in need of intensive monitoring. The target for the PCSA is to achieve (and maintain) 100% in each of the identified compliance items. The federal oversight requires the 100% compliance.

Specific information regarding the scoring procedures used during the March Assessment can be found in the appendix section of this document.

The plan must also include a commitment on the part of the school for resources and professional development to increase overall outcomes for students with disabilities in **all** targeted areas.

Each school is required to submit a Special Education Compliance Plan Assurance Document. The principal/educational leader, Specialized Services Regional Manager, Special Education Supervisor and the Regional Superintendent sign the assurance on behalf of the entire school staff. This document is a commitment to the continuous oversight of the Special Education Oversight Action Plan (SOAP) and to the improved achievement of students with disabilities in each school.

The assurance document commits the school to strive for excellence in the following areas;

- Compliance (ongoing and measured annually)
- Professional development commitment on topics that effect students in special education, most notably, Least Restrictive Environment (LRE)
- Ongoing review and monitoring of compliance
- Implementation of the school Special Education Compliance Plan
- Commitment of IDEA funds to implement IEP services and compliance activities, including using staff appropriately
- Ongoing evaluation of effectiveness of all special education strategies
- Imbedded School Improvement goals that target the improvement of special education achievement, attendance, truancy, graduation rates and family engagement while reducing truancy and discipline issues.
