On July 1, 2018, the Milwaukee Board of School Directors and Edgenuity Inc. ("**Contractor**") entered into Professional Services Contract number B0001328 ("**Contract**") with a term of July 1, 2018 through June 30, 2019. The Contract, (¶ 2), provided for two additional one-year extensions upon mutual written consent of the parties and in consideration of the performance metrics listed therein. Based on the Contractor's achievement of those performance metrics, the parties now mutually agree to extend the Contract for the second and final one-year term.

2. Paragraph 1 (Scope of Services) is modified to state the maximum number of students under this award is 1,000. Additional student access may not be purchased without prior approval from the MPS Administration.
