### Administration Response:

Administration would like to note that this amendment as originally presented moved funds from the referendum to the regular budget as presented. Administration has provided an alternate place to move the funding within the referendum. By changing where the funding is allocated this is simply a reallocation of referendum funding.

Administration would also note that there is \$285,000 budgeted already on page 3c-102 of which \$200,000 supports tuition for the bilingual teacher pathway. This amendment would add an additional \$200,000.

Please note that this reduces our efforts to redesign Human Resources. The administration supports this item if another funding source is used. Administration proposes using funding from Advanced Academics (R-6) to fund this item.
