Stat. 66.1005, vacation of the Affected ROW shall not terminate or affect easements and rights incidental thereto that belong to any county, school district, town, village, city (including Milwaukee), utility, or person that relate to any underground or overground structures, improvements, or services or to rights incidental thereto, including rights of entrance, maintenance, construction and repair.


