Wisconsin DPI	WI DPI - CTE Technical Incentive Grant	30,756	This appropriation incentivizes school districts to support career and technical education (CTE) programming, which results in an industry-recognized certification designed to mitigate workforce shortages in industries or occupations identified in consultation with the Department of Workforce Development (DWD) and the Wisconsin Technical College System (WTCS).
Wisconsin DPI	WI DPI - 21st Century CLC grant (16 sites)	1,535,000	<p>21st Century Community Learning Centers are programs designed to provide students with academic support, enrichment, and youth development opportunities in an after school setting. "CLCs support and strengthen student outcomes in schools with an improvement status such as Title I focus. CLCs...enroll students who may be at risk for academic failure, dropping out of school, involvement in criminal or delinquent activities, or who lack strong positive role models" (WI DPI).</p> <p>The current cohort of DPI funding proposals includes requests from 16 sites, ranging from K-8 locations to high schools. Records project the funding request at \$2,125,000 and approximately 3,500 students throughout the city of Milwaukee are projected to participate in programming at these sites.</p>
WI Dept Workforce Dev	Youth Apprenticeship (C&I)	225,000	This grant will increase Milwaukee Public Schools' youth apprenticeship enrollment to 250 students. In order to accomplish this goal, we will be requesting increased involvement from our school-based coordinators, with additional support provided by assistant principals. In addition, the business community will be called upon to work more collaboratively with Milwaukee Public Schools so that all appropriately prepared students will have opportunities to work in environments related to their career pathways. This grant will cover half the salary of the regional youth apprenticeship coordinator, provide additional funding for nurse aid training costs, provide stipends to school-based coordinators, and provide funding for part-time staff to assist the regional youth apprenticeship coordinator with administrative duties.
Northwestern Mutual Fnd	Northwestern Mutual 9th Grade Technology (Reagan)	20,000	Reagan will develop a Girls in Technology program in collaboration with Northwestern Mutual, Women in Technology Inc., and Girls Who Code with the goal of diversifying the IB Career-related Programme technology pathway by empowering female students to pursue technology careers. This program will recruit 30 9th grade female students and will include weekly Girls Who Code workshops through higher education partnerships.
