MILWAUKEE BOARD OF SCHOOL DIRECTORS PROFESSIONAL SERVICES CONTRACT SECOND EXTENSION & MODIFICATION

On December 7, 2021, the Milwaukee Board of School Directors and ENA Services, LLC entered into Professional Services Contract number C030294 ("Contract"), with a term of July 1, 2022 through June 30, 2023. The Contract, Section 2, provides for the possibility of four additional one-year extension terms to be exercised solely at the discretion of MPS. MPS subsequently exercised the first extension, extending the contract for a second term, from July 1, 2023 through June 30, 2024. The parties now mutually agree to extend the Contract for a third one-year term.

As such, the Contract will be extended for a third term, from July 1, 2024 through June 30, 2025 ("Year 3"), under the same terms and conditions as set forth in the original Contract and First Extension, except for those specifically set forth below. Exhibit A to the Contract, which remains unchanged, is attached hereto for reference.

In accordance with Section 19 of the Contract, the parties modify the terms identified below:

MODIFIED TERM:

- 1. Section 2(A) of the Contract is modified as follows: Subsection 2.A.ii is added which states "Year 3. This Contract shall be extended for a third term from July 1, 2024 through June 30, 2025."
- 2. Section 3(A) of the Contract is modified as follows: Subsection 3.A.ii is added which states "Year 3. The total costs of the services under this Contract shall not exceed \$247,200 for the term July 1, 2024 through June 30, 2025.
