**MILWAUKEE BOARD OF SCHOOL DIRECTORS
PROFESSIONAL SERVICES CONTRACT EXTENSION & MODIFICATION**

On February 28, 2014, the Milwaukee Board of School Directors and McCain Foods USA, Inc. entered into Professional Services Contract number B0001135, with a term of July 1, 2014 through June 30, 2015. The Blanket Contract, ¶ 2, provided for up to four additional one-year extensions by mutual consent and Board approval. The parties mutually agree to extend the Blanket Contract for the first additional one-year period.

As such, the Blanket Contract will be extended for an additional one-year term, from July 1, 2015 through June 30, 2016, under the same terms and conditions as set forth in the original Blanket Contract, except for those specifically modified below.

The amount to be encumbered in this second year of the Contract shall not exceed \$7,100.00.

In accordance with ¶ 19 of the Contract, the parties modify those terms and conditions identified below.

MODIFIED TERMS:

1. Paragraph 1 of the Contract is modified as follows: the existing table found in subparagraph 1 is replaced with

3. Paragraph 29 of the Contract is modified as follows: the existing text is replaced with "The HUB requirement on this Contract is 0%. The student engagement requirement of this Contract is 0 hours. The Career Education requirement for this Contract is 0 hours. Failure to achieve these requirements may result in the application of some or all of the sanctions set forth in Administrative Policy 3.10, which is hereby incorporated by reference."
