SECOND EXTENSION & MODIFICATION**

On July 1, 2016, the Milwaukee Board of School Directors and The Father's Table, LLC (“Contractor”) entered into Blanket Contract (“Contract”) number B0001204, with a term of July 1, 2016 through June 30, 2017. The Contract, ¶ 2, provided for up to two additional one-year extensions by mutual consent and with Board approval. The parties mutually agreed to extend the Contract for the first one-year extension period and executed a Contract Extension and Modification (“the First Extension”) to that effect in July 2017.

The parties now mutually agree to extend the Contract for second and final additional one-year term, from July 1, 2018 through June 30, 2019, under the same terms and conditions as set forth in the original Contract, except for those specifically modified below.

In accordance with ¶ 20 of the Contract, the parties modify those terms and conditions identified below.

MODIFIED TERMS:

1. The tables found in Paragraph 1 of the Contract and Paragraph 1 of the First Extension are deleted in their entirety and replaced with the table below. All other text of Paragraph 1 of the Contract remains unchanged.
